DESCRIPTION

These refurbished managed offices are situated at first floor level within Wythenshawe town centre and benefit from double glazed window units, good natural light, power/data trunking, heating, internal decoration, new carpeting and lighting.

FIRST FLOOR

Rents are inclusive of rent, buildings insurance, electricity, cleaning of communal areas, repair and maintenance of common parts within the building, lift maintenance, fire alarm system maintenance, external window cleaning, on-site security, water charges and broadband services (details to be confirmed). Tenants are responsible for their own telecoms, business rates (if any) and internal cleaning of the offices.

CAR PARKING

Each office suite will have an allocated car parking space (or on a ratio of one space per 300sq ft on larger lets) included in the rent, although, further car parking spaces are available, if required, at a cost of £30 per space per month. There is also free visitor car parking for up to 2 and 3 hours.



There is 24 hour, manned, on-site security/CCTV. The Town Centre gates are open from 6.00am to 8.00pm, although access is available outside these hours by arrangement. Each office has a door release/intercom handset to operate the main ground floor entrance door.
